**SERVICE REQUIREMENTS**

The minimum Child Days of Enrollment (CDE) Requirement shall be amended by deleting reference to 12,215.0 and inserting 12,150.0 in place thereof.

Minimum Days of Operation (MDO) Requirement shall be 180. (No Change)
